Please note: **The opportunity to participate in the Event is offered on a first-come-first served basis.** These tickets DO NOT guarantee admission to the Event or the chance to win a prize of a ticket to the advanced screening of "Squid Game" Season 2. Even if you register for the Event and/or are issued a ticket to the Event as well as showing up at the designated location at 6:00pm PT, you may not be admitted to the Event; and, in such case, Sponsor/Administrator, and "Squid Game" brand ambassadors (also referred to as "Squid Game" Ambassadors"), expressly disclaim any liability under any legal theory.

Between November 21, 2024 and December 11, 2024 the exact location of the Event ("**Event Location**") as well as arrival instructions/details will be emailed to registrants at the email address used to register for tickets to the Event. ANY AND ALL COSTS OF TRAVEL TO/FROM THE EVENT LOCATION, INCLUDING OVERNIGHT LODGING IF DESIRED, ARE THE SOLE RESPONSIBILITY OF REGISTRANT AND HIS/HER/THEIR GUEST.

Step 2 (Arrival, Check-In & Event Waiver)

On December 12, 2024 on or around 6:00pm PT, check-In begins & pre-run activities open. Again, admission to the Event – regardless of whether you registered for a ticket to the Event and/or are issued a ticket to the Event as well as showing up at the designated location at 6:00pm PT, is offered on a **first come, first served basis** and are **NOT** guaranteed. **For this reason, we strongly suggest arriving at the designated location early to secure your place in line. Line queues will open at approximately 4:00pm PT.**

At check-in each registrant and guest will be required to complete a Event waiver ("**Event Release Waiver**"). You must agree to abide by and be bound by these Official Rules, and the decisions of Sponsor/Administrator (as well as "Squid Game" brand ambassadors conducting the Elimination Challenges), all of which are final and binding in all respects and not subject to appeal. Other restrictions apply to the nomination of a proxy, including the proxy signing documentation accepting such role on your behalf without liability of any kind to "Squid Game" brand ambassadors, or Sponsor/Administrator. Game” Season 2 will take place in a location in Los Angeles, CA within 2-3 miles of the location where the Event was held. For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

I UNDERSTAND AND AGREE TO ALL OF THE FOLLOWING:

- (1) **A purchase or payment of any kind is NOT required to register for or participate in the Netflix Squid Game 2 - 4.56K Run (“Event”).
